### PART I. TECHNICAL SUPERVISION

#### 1 GENERAL

#### 1.2 DEFINITIONS AND EXPLANATIONS.

Para 1.2.2. The explanation to the abbreviation "Guidelines (G4)" is amended as follows:

«Guidelines (G4) — Guidelines for ballast water management and development of ballast water management plans (G4) adopted by IMO resolution MEPC.127(53), as amended by IMO resolutions MEPC.306(73) and MEPC.370(80).».

#### **4 SHIPS SURVEYS FOR BALLAST WATER MANAGEMENT**

#### Para 4.2.1.2 is amended as follows:

".2 Ballast Water Record Book that can be electronic registration system—or part of another record book or system\_complying with IMO resolution MEPC.372(80), and at least containing information specified in the Appendix II to the Annex to the Convention (taking into account IMO resolution MEPC.369(80), as amended). The record Book is kept—maintained and stored in compliance with regulation B-2 of Annex to the Convention. The electronic record book can also be used for ships that are still using the D-1 standard (refer to resolution MEPC.371(80);".
