Text of CL:

We hereby inform that in connection with implementation of IMO circular MSC.1/Circ.1315/Rev.1 "Revised Guidelines for the Approval of Fixed Dry Chemical Powder Fire-Extinguishing Systems for the Protection of Ships Carrying Liquefied Gases in Bulk", the Rules for the Classification and Construction of Ships Carrying Liquefied Gases in Bulk shall be amended as specified in the Appendices to the Circular Letter.

**PART V. FIRE PROTECTION**

**3 FIRE FIGHTING EQUIPMENT AND SYSTEMS**

**Para 3.4.1** is replaced by the following text:

**"3.4.1** Ships in which the carriage of flammable products is intended shall be fitted with fixed dry chemical powder fire-extinguishing systems, approved by IMO circular MSC.1/Circ.1315/Rev.1 "Revised Guidelines for the Approval of Fixed Dry Chemical Powder Fire-Extinguishing Systems for the Protection of Ships Carrying Liquefied Gases in Bulk" for the purpose of firefighting on the deck in the cargo area, including any cargo liquid and vapour discharge and loading connections on deck and bow or stern cargo handling areas."
