PART III. EQUIPMENT, ARRANGEMENTS AND OUTFIT

8 LIFE-SAVING APPLIANCES

8.1 GENERAL

Para 8.1.6 is amended as follows:

"8.1.6 Besides the requirements specified in ~~the present this Part~~, life-saving appliances shall comply with the requirements of ~~6.1.1, Part II "Life Saving Appliances" of the Rules for the Equipment of Sea Going Ships~~ 1.2.2 of the LSA Code".

8.2 EQUIPMENT OF SHIPS WITH LIFE-SAVING APPLIANCES

Para 8.2.1.1.4 is amended as follows:

".4 at least four lifebuoys, two of which shall be equipped with self-igniting lights to meet the requirements of ~~6.2.2, Part II "Life Saving Appliances" of the Rules for the Equipment of Sea Going Ships, when the ship is engaged in night voyages~~ 2.1.2 of the LSA Code when the ship is engaged in night voyages."

8.4 REQUIREMENTS FOR LIFE-SAVING APPLIANCES AND LAUNCHING APPLIANCES

Para 8.4.3.12 is amended as follows:

"8.4.3.12 Liferafts, lifebuoys and lifejackets shall meet the relevant requirements of ~~Section 6, Part II "Life Saving Appliances" of the Rules for the Equipment of Sea Going Ships except those especially stated in this Part~~ the LSA Code except those especially stated in this Part."
