We hereby inform that the Rules for the Classification and Construction of Chemical Tankers shall be amended as specified in the Appendices to the Circular Letter.

It is necessary to do the following:

**RULES FOR THE CLASSIFICATION AND CONSTRUCTION OF CHEMICAL
TANKERS, 2022,**

PART I. CLASSIFICATION

1 GENERAL

- 1 **Para 1.2.1.** Definition "Lining" is replaced by the following text:

"Lining is an acid-resistant material that is applied to the tank or piping system in a solid state i.e. not spray on.".

PART IX. MATERIALS OF CONSTRUCTION

1 GENERAL

- 2 **New para 1.3** is introduced reading as follows:

"1.3 Linings for cargo tanks and pipings.

1.3.1 The requirement for the elasticity of a lining to be not less than the supporting boundary plating is to prevent debonding at the interface between the lining and the lined surface.".
