We hereby inform that IACS Common Structural Rules for Bulk Carriers and Oil Tankers published on 1 January 2019 shall come into force on 1 July 2019.

Within the framework of implementation into the RS normative documents, the aforementioned Rules shall be included into the Common Structural Rules for Bulk Carriers and Oil Tankers, 2019, ND No. 2-020101-120-E, which, upon entering into force (on 1 July 2019), shall replace and withdraw Part XVIII "Common Structural Rules for Bulk Carriers and Oil Tankers" of the Rules for the Classification and Construction of Sea-Going Ships, 2019.
