Text of CL:

We hereby inform that the Guidelines on Technical Supervision of Ships under Construction shall be amended as specified in the Appendices to the Circular Letter.

It is necessary to do the following:

- 1. Bring the content of the Circular Letter to the notice of the RS surveyors involved in the technical supervision of ships under construction.
- 2. Apply the provisions of the Circular Letter when performing technical supervision during construction of ships contracted for classification under construction on or after 01.09.2021.
- 3. Apply the provisions of the Circular Letter when performing technical supervision during construction of ships contracted for classification under construction before 01.09.2021, as far as reasonable and practicable.

Shipbuilding and Repair Quality Standard

1 The title of the Appendix is supplemented by the number and date of a new revision of IACS Recommendation No. 47 "(Rev.9 June 2021)".

PART A SHIPBUILDING AND REMEDIAL QUALITY STANDARDS FOR NEW CONSTRUCTION

- 2 **Contents**. **Para 3.3** is replaced by the following text:
 - "3.3 Qualification of NDT operators".
- References. Reference A13 is deleted. References A14 A17 are renumbered A13 A16, accordingly.

Existing reference A14 (new reference A13) is replaced by the following text:

- "A13. IACS UR W33 "Non-destructive testing of ship hull steel welds"".
- 4 **Para 1.3**. References A13, A14 are introduced, reference A17 is deleted.
- 5 **Para 3.3** is replaced by the following text:

"3.3 Qualification of NDT operators

Personnel performing NDT for the purpose of assessing quality of welds in connection with new construction covered by this standard, are to be qualified in accordance with Classification Society rules or to a recognized international or national qualification scheme. Records of operators and their current certificates are to be kept and made available to the Surveyor for inspection."

- **3.3.1** Personnel performing NDT for the purpose of assessing quality of welds in connection with repairs covered by this standard, are to be qualified in accordance with the Classification Society rules or to a recognised international or national qualification scheme. Records of operators and their current certificates are to be kept and made available to the Surveyor for inspection."
