Text of CL:

We hereby inform that the Rules for Technical Supervision During Construction of Ships and Manufacture of Materials and Products for Ships shall be amended as specified in the Appendices to the Circular Letter.

It is necessary to do the following:

- 1 Bring the content of the Circular Letter to the notice of the RS surveyors, interested organizations and persons in the area of the RS Branch Offices' activity.
- 2 Apply the provisions of the Circular Letter during review and approval of the technical documentation on products as well as when performing technical supervision during manufacture of products, when the requests for service rendering listed above are received on or after 15.02.2022.
- 3 Apply the provisions of the Circular Letter when performing technical supervision during construction of ships contracted for classification under construction on or after 15.02.2022.
- 4 Apply the provisions of the Circular Letter when performing technical supervision during construction of ships contracted for classification under construction before 15.02.2022, as far as reasonable and practicable.

- **"13.9** The RS technical supervision during mooring and sea trials of equipment and the ship carried out in compliance with the requirements of Section 18 of the Guidelines aims at checking their conformity with the approved (agreed) technical documentation, the RS rules and standards as well as with the provisions of international conventions applicable to the ship under construction."
